TEACHING

Assistant Professor

ACAD 101: Principles of the Learning Academy

This is an essential course for all first-time freshmen. This course introduces first-year students to the concepts, principles, and skills necessary for successful higher learning and facilitates students' adjustment to and engagement in the learning academy.

SCWK 321: Social Welfare as Social Institution, (BSW) Winthrop University Fall, Spring, 2017-current

The purpose of this course is to help students understand what drives social welfare policy, the values and beliefs underlying social welfare policy, and how it impacts our lives. The course is designed to be theoretical and practical. Fundamental concepts and theories of social welfare policy are examined. The competing values and beliefs that influence social welfare policy are discussed and analyzed. An overview of the history of social welfare policy in the United States is explored. Social welfare policies and programs are examined within the context of the social problems they address.

SCWK 330: Research Methods (BSW), Winthrop University, Fall, Spring 2014-to current

The main goals of SCWK330 are the study of research concepts, designs, methodologies, and stages of the research process. Emphasis will be on the acquisition of knowledge and development of skills to evaluate professional literature and generalist social work practices. *NOTE:* This is an intensive writing course. Please see the guidelines for intensive writing courses listed on the Winthrop University Internet Web site and on Blackboard. (Three credit hours). The course is offered in fall and spring.

SCWK 473: Independent Research: Attitudes Towards Mental Health, (BSW) Winthrop University Fall, 2017

The focus of this course is to explore student's attitudes towards mental health. The student will conduct a quantitative study that will enable her to determine the extent of attitudes towards mental health, and how the attitudes vary by classification, as well as programs.

SCWK 473: Independent Research: Hispanic Women and Healthcare Access: An Exploratory Study (BSW) Winthrop University Fall, 2016

The focus of this course is to develop an understanding of the role of social capital in improving academic performance among vulnerable campus populations, specifically first generation college students.

SCWK 550A: Special Topics: International Community Practice in St. Vincent and the Grenadines, (BSW & MSW) Winthrop University, (*study abroad*), Summer, 2017

This course provides students with the experience of practicing community social work in St. Vincent and the Grenadines. Students will learn about the social, economic, and environmental community challenges facing Vincentians. They will have the opportunity to engage in a community development project.

SCWK 550C: International Community Practice (BSW), Winthrop University, Spring 2017

This course will prepares students to do community development work in an international setting. It will introduce students to the different dimensions of community development - social, economic, and environmental. The course will also shed light on the complex developmental issues, and present empowerment strategies and approaches that can be used in enhancing global communities.

SCWK 550C: Special Topics in Social Work: Social Capital and Academic Performance of First Generation Students (BSW), Winthrop University, Fall 2015

The focus of this course is to develop an understanding of the role of social capital in improving academic performance among vulnerable campus populations, specifically first generation college students.

SCWK 550 C: Special Topics in Social Work: International Social Work and Global Nutrition in St. Vincent and the Grenadines, (BSW & MSW), Winthrop University (*study abroad*), Summer 2015

This course provides a cross-cultural experience in which students learn about Vincentian culture, human rights, social development, and social welfare issues. Students will explore the effects of poverty and the physical environment on individuals and their communities as a whole. Further, students will learn about the service delivery approaches being used to address the social needs of Vincentians. Students will visit social service agencies in many of the traditional social work fields of practice (family and children, health, mental health, education, corrections).
