Key outcomes of this assignment include enhancing the command presence of the Washington state's COVID-19 response, successfully responding to the Monkey Pox Outbreak, developing emergency preparedness and response leadership capacity within the agency, establishing advanced development of emergency preparedness, resilience and emergency response capabilities, and strengthening relationships to support inter-agency preparedness and response efforts.

This role involved hiring and on-boarding staff, making difficult decisions to retain probationary personnel, addressing agency-level safety and security issues from a strategic and leadership level, and making durable and high-impact budgetary decisions to maintain and improve 14 leased and owned agency facilities.

- My primary role was to implement the policy direction set by the Secretary of Health and the Chief of Emergency Preparedness and Response. This included providing strategic and policy direction to the Washington State Department of Health's emergency preparedness and operational readiness efforts.
- Major initiatives involved building sustainable statewide emergency response capability to save lives in disasters impacting the citizens of Washington State, and leading interagency public health and medical efforts within the Governor's Resilient Washington State Sub-Cabinet to improve the state's disaster resilience.
- This position allowed me the opportunity to work closely with a talented leadership team, as well as agency, inter-agency, local, and tribal partners in developing and implementing a shared statewide strategy for emergency preparedness and response.
- Programmatically, I led the agency's public health response team development, training, exercising, emergency planning, and the logistical efforts necessary to mount a statewide public health response effort.
- As a leader, this role gave me the opportunity to demonstrate an ability to coach and mentor new leaders in the field of public health emergency preparedness and response. I have also provided training to more than 500 people across the state of Washington in Incident Command, Incident Leadership, or crisis leadership.
- In this role, I also served as an Incident Commander for the agency's Type 3 Incident Management Team, leading response to more than 17 large scale or novel and highly political crises.

Director - Emergency Preparedness Unit, Department of Health - Office of Emergency Preparedness and Response

- Provided strategic direction to the agency's Office of Emergency Preparedness and Response and coordinated with external stakeholders and partners to develop a shared statewide strategic direction for this work. These efforts included taking a leadership role in building the office's strategic plan, as well as a statewide strategic matrix for PHEPR activities.
- Programmatically, I oversaw the agency's operational readiness for public health emergencies and other disasters. Operational readiness included the creation of the agency's Incident Management Team, response team development, training, exercises, emergency, and continuity of operations planning, as well as maintaining the logistical infrastructure to mount a public health response effort. In this effort, I led other leaders who are responsible for the design and implementation of these efforts.
- The focus of this work was around developing core competencies and developing performance measures to better track our progress toward building Public Health Emergency Preparedness and Healthcare Preparedness Program emergency response capabilities.
- As a leader, I influenced the development of my team members who are now operating at more sophisticated and complex levels of leadership in the emergency management field. This included several of my team members being promoted within and outside of the department, and many team members speaking at state and national level conferences, serving on state and national boards, and conducting advanced level training in their subject matter areas.

Multi-County Regional Public Health Emergency Response Coordinator

March 2006 – December 2012

- At the peak of this program's funding, I directly supervised six FTEs, 364 Medical Reserve Corps Volunteers, and managed a \$1.5 million budget made up of county general funds, as well as state and federal grants directed at public health emergency preparedness and response.
- In this position, those I supervised produced multiple peer reviewed publications, presented at state and national level conferences, and received national recognition for their work including a NACCHO Model Practice Award and a Kennedy School of Government Bright Ideas in Government Award.

- My focus was leading inter-jurisdictional and inter-disciplinary public health, healthcare, and all-hazards preparedness efforts. This focus included staffing a board of directors, the Region IV Governing Council, responsible for directing collaborative public health system and public health preparedness activities in the four counties and the Native American tribe occupying Southwest Washington.
- One of my major achievements is developing and leading the Region IV Public Health Incident Management Team.
- In more than 17 responses to public health emergencies, including the H1N1 pandemic, I led regional response efforts. These events often involved multiple jurisdictions and agencies, spanned multiple days to weeks, required written Incident Action plans, and required up to 110 responders.

State Bioterrorism Epidemiologist

- The focus of this position was leading the development of a surveillance system for unexplained illnesses and deaths occurring in Louisiana. This was a collaborative effort between the Louisiana Office of Public Health, parish (county) and city coroners, and hospitals. I was also responsible for infectious disease investigation activities conducted in Louisiana's Capital Region. This included establishing and maintaining rapport with local hospital infection control staff, overseeing appropriate follow-up, directing physician intervention, implementing community education activities, and monitoring parish health units and hospitals conducting surveillance activities via electronic reporting.
- Developed Louisiana Office of Public Health staff's and response partner's professional skills in recognizing and responding to biological agents, infectious diseases, and other public health emergencies.
- Served on the State of Louisiana's Infectious Disease Rapid Response Team where I served in a leadership role during multiple disease outbreaks and natural disasters including West Nile Virus Outbreaks and Hurricanes Katrina and Rita.

Public Health Program Evaluation Contractor

National Network Public Health Institutes, New Orleans, LA

• The primary focus of this position was to build the capability of National Network of Public Health Institutes (NNPHI) staff to conduct process evaluations of their technical assistance program. In this role, I led the design and implementation of a

comprehensive evaluation plan for the "Fostering Emerging Institutes Project" while mentoring NNPHI staff to develop their program evaluation skills.

 Assisted NNPHI staff in developing a formal system for documenting the impact of technical assistance provided to emerging state public health institutes by both NNPHI staff and NNPHI mentors.

State Trauma System Epidemiologist

Medical Center of Louisiana New Orleans (Charity Hospital), New Orleans, LA

May 1999 – December 2001

 Having worked in Emergency Medical Services prior to beginning graduate training in public health, my educational focus was on injury epidemiology and trauma systems development. Beginning as a graduate intern, I served as the epidemiologist and injury prevention program evaluation specialist.

INCIDENT RESPONSE AND CRISIS MANAGEMENT EXPERIENCE

- 1995-1999: In the formative years of my career, I worked in remote areas of Wyoming, including Yellowstone National Park, providing pre-hospital emergency medical care from the nation's only seasonal hospital (at that time).
 - Working with limited resources in austere environments, I responded to multiple wildland fires, aircraft crash rescues, search and rescue missions, and multi-casualty incidents.
 - These early experiences included extensive mentoring that helped me build a strong foundation as a disaster responder and as a crisis leader.
- 2000-2003: Living in New Orleans, Louisiana, I became involved with multiple community-based disaster preparedness, resilience, response, and recovery efforts, as part of my academic work in Public Health.
 - This included research on public messaging around biological and chemical terrorism within urban populations typically disproportionally affected by disasters because of race, age, disabilities, economics, or social factors.
 - This work greatly expanded my awareness of structural racism, health equity, and the role of social disparities in complex crisis.
- 2004-2006: Working as the State of Louisiana's Bioterrorism Epidemiologist, I had the opportunity to respond to the emergence of West Nile Virus outbreaks that were impacting many Gulf Coast states. I also had the opportunity to assume leadership roles in multiple disease outbreak responses.
 - I served in mid-level leadership roles during several hurricane response efforts including an inter-state mutual aid response to Hurricane Ivan in 2004, the prolonged state response to Hurricane Katrina, and Hurricane Rita.

- During Hurricanes Katrina and Rita, I worked closely with National Disaster Medical System teams, serving as the state liaison to both Disaster Medical Assistance Teams and to the Disaster Mortuary Operations Team. This expanded my leadership skills related to disaster response and expanded my view of the federal HHS response capability.
- 2007-2012: Following Hurricane Katrina, I was recruited to Washington State to support the development of public health and medical response capabilities. Over these years, I led response teams as well as Incident Management Teams in over 20 Type 3 (high complexity) public health and all hazards response efforts.
 - I led emergency response efforts by building and leading the Multi-Agency Coordination Center for Public Health and Medical Response, as well as serving as the incident commander on behalf of four independent county public health agencies and one tribal public health department during the H1N1 pandemic in 2009.
 - Through these experiences, I shifted from functioning as a response team leader to mentoring and coaching response team leaders. During this time, I also became involved with the US. Health and Human Services Incident Response Coordination Team.
- 2012-2017: Having successfully demonstrated a professional ability to develop emergency response leaders and to affect cultural and organizational change to align public health agencies more highly with a responder orientation, I was promoted to the state level to help the Washington State Department of Health build its capability to function as a responder organization.
 - Over this time, I led the Washington State Department of Health response to 19 state-level and multi-state regional emergencies. These included the SR-530 Oso, Washington landslide, the Ebola Virus Event, two of the largest firestorms in Washington State history, and several novel crises - lead in a prominent city's water system, opioid-related response related to a regional pain clinic closure, and radiologic materials issues.
 - I also responded to the following incidents and National Security Special Events with the US HHS IRCT:
 - 2015, Papal Visit- Staging Area Manager and Task Force Leader
 - 2016, Republican National Convention- HHS SOC EMG Operations Augmentee

 - These experiences considerably refined my crisis leadership skills and helped me become more aware of how leaders can best support resilience of team members, partners, and stakeholders in crises. In turn, I've become better able to coach and mentor other crisis leaders in positive and meaningful action.

- 2018-2020: Settling into a new role as an office director in the Washington State Department of Health.
 - In a director-level role, my focus shifted toward developing resilient organizations, and mentoring the next generation of public health and emergency response professionals. I engaged in multiple mentorship and coaching arrangements, and seized opportunities to develop organizational resilience among the teams I lead as well as with other teams interested in these types of efforts.
- 2020-present: I stepped back into emergency response with the COVID-19 pandemic. During this time, I have served as the Incident Commander for the Department of Health's initial response to the pandemic between January and March 2020, as the Area Commander for the state COVID-19 response from March until August, and providing leadership to challenged local health jurisdictions from September until December. Beginning in January 2021, I assumed the role of Deputy Incident Commander focused on non-vaccine response efforts.
 - In these roles I have developed skills for effectively working with elected officials in high profile crises, achieving inter-agency agreement and coordination, and supporting teams that are approaching burnout but must continue to persevere with insufficient resources.
