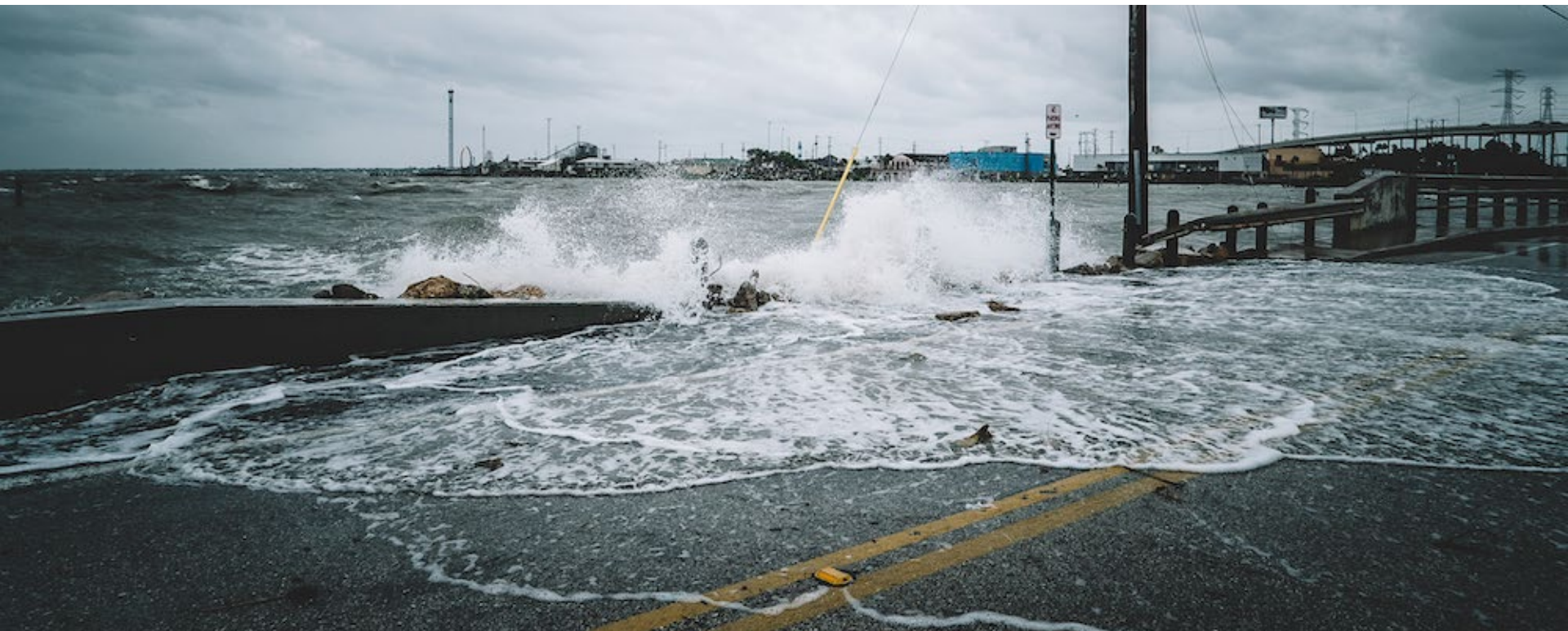

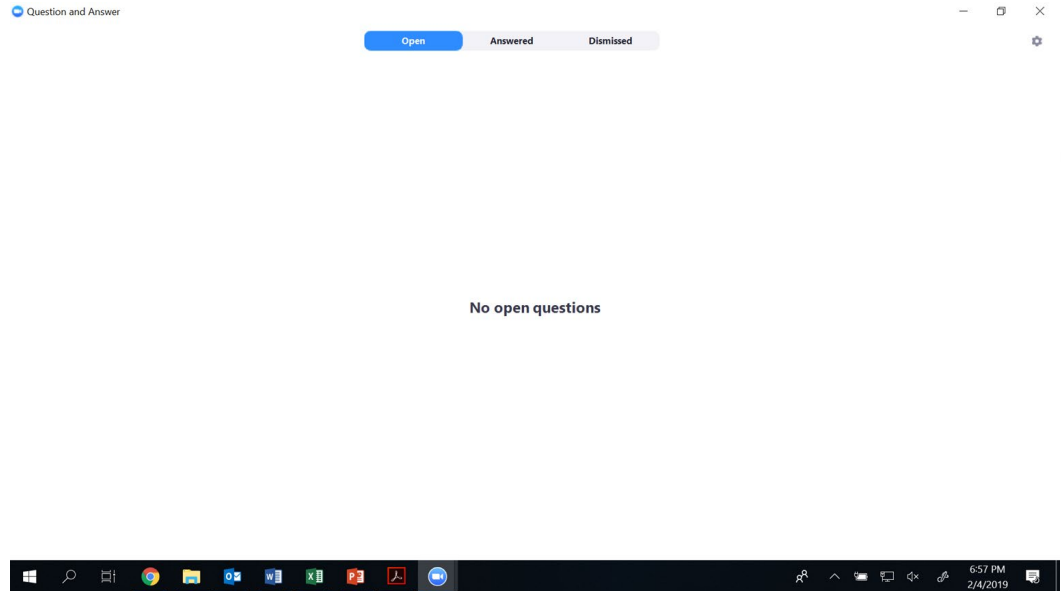

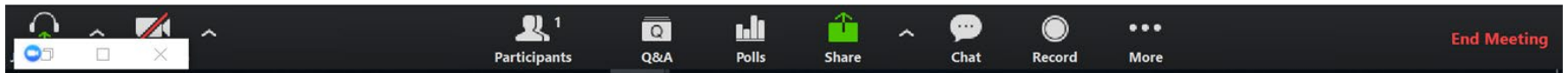

As continuing floodplain development, climate change, and other social and environmental forces drive U.S. flood risk, *retreat*—removing development from and relocating people out of high flood-risk areas—is an increasingly necessary and widespread practice.



This presentation will use the findings from two recent studies on floodplain buyout implementation practices to discuss opportunities to reduce costs, increase the speed with which buyouts are made available to prospective participants, and increase equity in floodplain buyouts.

His work spans climate adaptation and retreat, supportive housing systems, land use regulation, housing affordability, active transportation, and public health. Curran-Groome's research on floodplain buyouts examines how funding and policy mechanisms influence buyout costs and quality and points to opportunities to improve project outcomes and to make buyouts more widely available.
