


### Mitigation Planning Nationwide

More than **25,535 local governments** have current local mitigation plans.


**246 tribal governments** have current tribal mitigation plans.





# **Equity in the 2022 Policies**

# Why Include Equity?

- Mitigation plans support risk reduction for the whole community.
- Plans are a chance to counter systematic barriers and reduce risk for all.





### **Equity in State Mitigation Plans**



- Must describe how effective local mitigation efforts are. This includes gaps and disparities in serving underserved and socially vulnerable populations.
- Should consider these groups when prioritizing jurisdictions to receive grant funding.



### **Equity in the State Planning Process**



- Describe how the state coordinated with agencies whose programs support socially vulnerable and underserved communities.
- Describe how the state coordinated with other groups that support these communities.



### **Equity in the State Risk Assessment**



- Analyze the vulnerability of jurisdictions with respect to the impacts to populations. This includes socially vulnerable and underserved communities.
- Summarize recent and projected development. This includes demographic changes that put certain communities at risk.




# **Guidance for State Planning**

## **Equity in the Local Mitigation Planning Process and Risk Assessment**



#### Planning process must:

- Describe how the process gave stakeholders that represent socially vulnerable and underserved communities the opportunity to participate.
- Document how the public, including members of underserved communities, had the chance to participate.



#### Risk assessment must:

 Describe the vulnerability of each jurisdiction. This includes socially vulnerable and underserved communities.



### **Equity in the Local Mitigation Strategy**



- Include actions that benefit underserved communities and socially vulnerable populations.
- Evaluate actions using qualitative benefits. This includes how they benefit underserved and socially vulnerable communities.



### Non-FEMA Resource: Climate and Economic Justice Screening Tool

- Climate and Economic Justice Screening Tool (CEJST).
  - Identifies disadvantaged communities at a census tract level through standardized, nationally consistent data.
  - Considers communities disadvantaged if they meet two criteria. First, they must be in a census tract that meets the threshold for at least one of the tool's categories of burden.
     Second, they must meet the threshold for a corresponding economic indicator.
  - Considers communities disadvantaged if they are on the lands of a federally recognized tribe.
- Criteria used for grant scoring criteria and grants with an equity standard.



### Hazard Mitigation and Climate Adaptation – Additional FEMA Resources
