#### Accessing federal funding

**The problem:** New flood risk maps indicate that flood risk in Three Forks is far higher than previously understood.

**How we helped**: We helped Three Forks understand and prioritize its range of options to decrease flood risk. We hired an engineering firm to conduct a feasibility study of mitigation options. Their study demonstrated that building a wide, shallow conveyance channel would divert flood water around and away from the city. The \$5 million project
